

Samsung Galaxy S24 Real Device Bundle Offering Terms & Conditions

- 1. Incorporation by reference in addition to:
 - i. The General Terms and Conditions of Service;
 - ii. Imagine Mobile Postpaid Service Terms and Conditions; and
 - iii. Imagine Device Bundle Terms and Conditions.

Which terms and conditions are deemed to be incorporated by reference, the Customer shall be bound by the following Specific Terms and Conditions.

- 2. The Samsung Galaxy S24 Real Postpaid Device Bundle Offering offers Customers lowest price than retail price when they purchase a Samsung Galaxy S24 smartphone series bundled with a Real Postpaid Device Bundle Plan on a 24-month contract (hereinafter referred to as 'Offering').
- 3. This Offering is valid from 25th January 2024 30th January 2024 (pre-order Period) and will be offered as a permanent offering under Real Postpaid Device Bundle plans (hereinafter referred to as 'Offering Period').
- 4. This Offering is applicable for all new and existing customers who wish to subscribe to a Real Postpaid Device Bundle Plan as follows:
 - i. Sign-up or recontract to a Real Postpaid Device Bundle Plan

- 8. Customers who sign up for Samsung S24/S24+/Ultra will be required to pay one (1) month advanced rental for the Samsung S24/S24+/Ultra Real Postpaid Device Bundle Offering.

 - i. In the event that an existing Device Bundle or Real Postpaid Device Bundle Customer wishes to subscribe for an additional Real Postpaid Device Bundle plan:
 - a. Customer is required to pay all necessary fees and charges, including but not limited to the rental charges for the remaining months of the contract period and remaining payments of the device determined by imagine; or
 - b. Customer may sign up to a new Real Postpaid Device Bundle Plan.

- 11. Customers who have successfully subscribed to this Offering are not allowed to upgrade or downgrade their Real plan for the duration of the contract period upon successful activation.

- 12. - i. All Samsung Galaxy S24 smartphone devices are covered by Incomm for a period of one (1) year limited warranty.
- ii. This warranty is valid for a period of one (1) year from the successful activation date of the service.
- iii. Customers may claim their warranty and provide a receipt of purchase from the applicable *imagine* centres at the Samsung Authorized Service Provider address as below:

17. Change of ownership

Any change of account ownership by the Customer, except in the event of death or otherwise as consented to by imagine, will be deemed as a breach of contract, and will require the customer to pay all necessary fees and charges, including but not limited to the rental charges for the remaining months of the contract period and installments of the device determined by imagine.

18. Early termination fees

Any early termination of the contract will incur penalty fees and charges. This may include but is not limited to a total of rental charges for the remaining months of the contract period and the cost of the device, or subject to imagine's discretion.

- 19. Customers are responsible for any loss, theft or damage to the Device at all times and shall continue to pay the total of rental charges for the remaining months of the contract period, if applicable, notwithstanding that the Device is lost or damaged.
- 20. imagine reserves the right to deem the offer void if the Customer does not comply with the Terms and Conditions specified for this Offering including imagine's General Terms and Conditions for Services as well as such other specific terms and conditions as may be agreed and accepted by the Customer. Such rights conferred by imagine under these terms and conditions shall be additional to the rights conferred by imagine under imagine's General Terms and Conditions for services and any other terms and conditions agreed and accepted by the Customer.
