5. Customers who are on an existing Device Bundle or any Real Postpaid Device Bundle Plan, or any service promotions or discounts, are eligible to subscribe with the following conditions:



6. In the event that an existing Device Bundle or Real Postpaid Device Bundle Customer wishes to subscribe for Simply Data Plan:
  - (a) Customer is required to pay all necessary fees and charges, including but not limited to the rental charges for the remaining months of the contract period and remaining payments of the device determined by imagine; or
  - (b) Customers who subscribe to Dream Bundle Plans must un-bundle their existing Dream Broadband and Simply Data Plan services and recontract their Dream Broadband Standalone to a 24-month contract term and Simply Data plan to a 24-month contract term, to be eligible for this Offer. The contract penalty will be waived if the Customer's Dream Bundle contract period is six (6) months or below.
7. Service cancellations for new Simply Data plan sign-ups  
Customers are not allowed to cancel their subscribed plan within the contract period. (based on the chosen contract Simply Data plan).
8. Upon the expiration of the contract, imagine shall notify Customers via email or SMS three (3) months before the expiry. Customers shall have the options to:
  - i. renew their service contract; or
  - ii. subscribe to a new device bundle promotion;
  - iii. request to Imagine for termination.
9. Service Recontract  
Upon service recontract, the charges would return the normal price of the plan the customer is subscribed to.
10. Change of ownership  
Any change of account ownership by the Customer, except in the event of death or otherwise as consented to by imagine, will be deemed as a breach of contract, and will require the Customer to pay all necessary fees and charges, including but not limited to the rental charges for the remaining months of the contract period and instalments (if applicable) or device penalty of the device determined by imagine.
11. Early termination fees  
Any early termination of the contract will incur penalty fees and charges. This may include but is not limited to a total of rental charges for the remaining months of the contract period and the cost of the device, or subject to Imagine's discretion.
12. In the event of any breach, dispute, enforcement, or legal proceedings arising from or relating to the rental of the telco promotional offers, all legal costs, and expenses (including but not limited to solicitor and client costs) incurred by imagine shall be borne by the Customer, client, guarantor, or the applicable contracting party, as the case may be.
13. Imagine reserves the right to deem the offer void if the Customer does not comply with these Terms and Conditions for this Promotion including Imagine's General Terms and Conditions for Services as well as such other specific terms and conditions as may be



agreed and accepted by the Customer. Such rights conferred by Imagine under these terms and conditions shall be additional to the rights conferred by Imagine under Imagine's General Terms and Conditions for services and any other terms and conditions agreed and accepted by the Customer.
