Terms & Conditions**

1. Incorporation by reference in addition to:
 - (a) The General Terms and Conditions of Service;
 - (b) Imagine Broadband Service Terms and Conditions;
 - (c) Imagine Mobile Postpaid Service Terms and Conditions;
 - (d) Imagine Device Bundle Terms and Conditions; and/or
 - (e) Imagine Real Device Bundle Terms and Conditions.

4. Customers who are not eligible for this Offer if:
 - (a) they have outstanding payments with Imagine; and/or
 - (b) their service is temporarily disconnected or temporarily out of service.
5. Customers who subscribe to a 24-month contract term may be eligible to receive one (1) complimentary MiFi device, subject to availability and applicable terms and conditions.

The complimentary MiFi device shall be subject to a standard manufacturer's warranty of twelve (12) months covering manufacturing defects only. The warranty shall not cover damage arising from misuse, negligence, unauthorised modification, accidental damage, or normal wear and tear.

In the event of loss, theft, or irreparable damage, the Customer shall be liable for the full replacement cost of the device. Imagine reserves the sole discretion to assess the condition of the device and determine any applicable charges.

6. Customers who are currently subscribed to an existing Device Bundle, Real Postpaid Device Bundle, Dream Bundle, or any promotional or discounted service may subscribe to this Offer subject to the following conditions:
 - (a) Customer is required to settle all necessary fees and charges, including but not limited to the rental charges for the remaining months of the contract period and remaining payments of the device determined by imagine; and/or
 - (b) Customers who subscribe to Dream Bundle Plans must un-bundle their existing Dream Broadband and Simply Data Plan services and recontract their Dream Broadband Standalone to a 24-month contract term and Simply Data plan to a 24-month contract

term, to be eligible for this Offer. The contract penalty will be waived if the remaining Dream Bundle contract period is six (6) months or less.

7. Service cancellations for new Simply Data plan sign-ups.
Customers are not allowed to terminate their Simply Data Plan subscription prior to the completion of the contracted term.
8. Upon the expiration of the contract, imagine shall notify Customers via email or SMS three (3) months before the expiry. Customers shall have the options to:
 - (a) renew their service contract;
 - (b) subscribe to a new device bundle promotion; or
 - (c) request to Imagine for termination.
9. Service Recontract
Upon service recontract, the charges would return the normal price of the plan the customer is subscribed to.
10. Change of ownership
Any change of account ownership by the Customer, except in the event of death or otherwise as consented to by Imagine, will be deemed as a breach of contract, and will require the Customer to pay all necessary fees and charges, including but not limited to the rental charges for the remaining months of the contract period and instalments (if applicable) or device penalty of the device determined by Imagine.
11. Early termination fees
Any early termination of the contract will incur penalty fees and charges. This may include but is not limited to a total of rental charges for the remaining months of the contract period and the cost of the device, or subject to Imagine's discretion.
12. In the event of any breach, dispute, enforcement, or legal proceedings arising from or relating to the rental of the telco promotional offers, all legal costs, and expenses (including but not limited to solicitor and client costs) incurred by Imagine shall be borne by the Customer, client, guarantor, or the applicable contracting party, as the case may be.
13. Imagine reserves the right to deem the offer void if the Customer does not comply with these Terms and Conditions for this Offer including Imagine's General Terms and Conditions for Services as well as such other specific terms and conditions as may be agreed and accepted by the Customer. Such rights conferred by Imagine under these terms and conditions shall be additional to the rights conferred by Imagine under Imagine's General Terms and Conditions for services and any other terms and conditions agreed and accepted by the Customer.
